<p>The Company has entered into three loan agreements with Provident Minerals Pte Ltd, dated 21 October 2022 and 15 February 2023 and 25 April totalling A\$8.6 million (including accrued interest at 30 June 2023). The interest on the loan dated 21 October 2022 is 10% per annum while the interest on the loans dated 15 February 2023 and 25 April 2023 is 12% per annum. These loans are classified as unsecured and rank pari passu with existing unsecured obligations. The maturity date for both loans is 30 September 2023. Approximately A\$3.8 million of these loans was repaid through the issue of shares in the entitlement offer at 30 June 2023. The remaining A\$4.8 million was repaid on 3 July 2023 (post quarter end).</p>
