Further drilling results from the company's Sihayo 1 North project has intersected shallow mineralisation on the southern flank of the Resource envelope. All holes were completed outside the current Inferred Resource of 7.1Mt @ 2.71g/t Au for 610,000 Oz Au. Better results include **SHDD063: 6m @ 4.37g/t Au** from surface and **SHDD064: 6m @ 3.34g/t Au** from surface.
