## Quarterly Cashflow Report - Amended

Sihayo Gold Limited (**ASX:SIH** – “**Sihayo**” or the “**Company**”) announces a minor amendment to the Appendix 5B for the December 2022 quarter released on 31 January 2023.

An error was identified whereby the loan facilities amount (Section 7) was stated as A\$1.5 million. The correct amount is US\$1.5 million, translating to A\$2.214 million at the applied exchange rate for the quarter.
