8.8.1 Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?	
Answer: No. The company expects a material reduction in operating costs and cash outflows. Project Optimisation Studies for its Sihayo Starter Project are expected to continue but with total expenditure levels declining. In addition, the number of drill rigs being utilised on exploration programs will decline from three rigs to one rig. There is also expected to be a modest reduction in overhead costs being incurred. In aggregate, there is expected to be a significant reduction in total expenditure.	
8.8.2 Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?	
Answer: Yes. The company is actively assessing options for raising additional funding during the next one to two months. The company is confident that it will be able to raise sufficient capital to fund ongoing operations given the support that its major shareholders have provided for previous capital raisings over a long period of time.	
8.8.3 Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?	
Answer: Yes. The company expects to raise sufficient capital in the next one to two months to allow planned activities at the forecast reduced spend rate to be maintained, during which time the company will also progress longer term funding options.
