	Answer: The Company announced on 26 April 2022 an Entitlement Offer to shareholders to raise up to \$11,793,477. The Entitlement Offer is underwritten by shareholders to \$9,666,667. These funds will be used to repay outstanding shareholder loans as well as provide sufficient working capital to continue the Company's activities. The Entitlement Offer is expected to be completed on 23 May 2022.

8.8.3 Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

Answer: Yes – the underwritten Entitlement Offer will provide sufficient working capital for the Company to continue its exploration and evaluation activities. Following the Entitlement Offer and repayment of the shareholder loans, the Company is expected to have a minimum of approximately \$6,000,000 cash on hand.
